



Privacy

In this privacy statement, we explain how personal information is collected and processed on just-green.no. We also tell you about your rights when storing personal information through a customer relationship with Just Green, and your right to have this information deleted. We will never share personal information with others, or use the information for purposes other than those stated in this statement.

Purchase of goods

To make a purchase on just-green.no, we need name, address and e-mail address.

This is necessary to send you your ordered goods, and to keep you updated on your delivery. We are required to store order information in connection with accounting and handling of fees and possible returns.

Payment

We use Stripe as a payment solution. Stripe is the data processor for personal data related to payment, and Stripe's privacy statement applies to the processing of personal data related to payment. You can find Stripe's privacy statement here: <https://stripe.com/no/privacy>.

Statistics

Google Analytics

We use Google Analytics to analyze how visitors use the website. The information stored is anonymous, and can e.g. be the number of page views, the number of visits, etc. The purpose is to increase the usability of the website, and get a picture of what visitors find interesting. The information is stored by Google Inc.

information cookies

Cookies are files that are placed on your device to collect standard information about the visitor and use of the website. Most of these capsules are necessary for the website to work and for you to be able to shop with us.

Advertising on Facebook or Google

We use cookies from Facebook and Google to be able to carry out targeted advertising on these pages, as well as track the response of this marketing. In this way, we can also exclude ads for users who we do not think will find our ads relevant.

Disable the use of cookies

If you do not want cookies to be stored on your device, you can disable this in your browser. Please note that this may lead to the website not working properly, and that you will not be able to complete your purchase with us.

Deletion of personal information

We will delete your personal information when it is no longer needed for the service we provide to you. We are required by law to keep certain information for a certain period of time in the interests of accounting legislation.

You can at any time request to have your information deleted, by contacting us. Our contact information can be found at the bottom of this page.

Your rights

You have the right to be informed of what personal information we store about you and how this information is processed. You can request the creation, deletion and restrictions in the processing of this information in accordance with the Personal Data Act.

The personal information is used on the basis of and in accordance with your consent. You can withdraw your consent at any time. Withdrawal of consent will not affect the legality of the processing of your personal data in the time until the consent was withdrawn.

If you believe that we have not complied with your rights in accordance with the Personal Data Act, you have the right to complain to the relevant supervisory authority. This is done by sending a complaint to the Norwegian Data Protection Authority.
